

How it works: The 50% Rule

The Federal Disabled Access Credit allows small businesses to reclaim 50% of expenditures spent on "barrier removal"—including digital communication barriers.

Example Calculation:

Total Remediated Spend	\$10,000
IRS Flat Subtraction	(\$250)
Eligible for 50% Credit	\$9,750
Total Tax Credit	\$4,875


Small Business Qualifications

To claim the credit, your business must meet one of the following thresholds from the preceding year.

Employee Count Threshold




The California Stacking Benefit

While the Federal Credit (Form 8826) provides a dollar-for-dollar reduction of your tax bill, California allows businesses to deduct the cost of barrier removal from their taxable income.

- Federal:** Apply 50% credit to the first \$10,250 of spend.
- California:** Deduct the remaining balance of the technical remediation project as a business expense.
- Section 190:** Benefit from expedited barrier removal deductions on your state return.

Does Kha Creation file the tax forms for me?

Does web remediation count as "barrier removal"?

Yes. The IRS and courts increasingly recognize digital accessibility as a communication barrier. Services like keyboard navigation fixes, alt-text for screen readers, and color contrast adjustments enable access for individuals with disabilities.

Can I claim this credit every year?

The Disabled Access Credit is an annual incentive. If you spend money on ongoing monitoring or new accessibility features in subsequent years, you may be eligible to claim the credit again for those new expenditures.

What are "Form 8826 Instructions"?

These are the IRS guidelines for the Disabled Access Credit. They define "eligible small businesses" and "eligible access expenditures." You can find them on the official IRS.gov website to verify your eligibility.

How does California handle this?

California conforms to federal Section 190, allowing for barrier removal deductions. This helps reduce your state-level tax liability in addition to the federal tax credit benefit.

What documentation do I need?

You need a detailed invoice from a technical specialist like Kha Creation. Our documentation specifically outlines the accessibility barriers removed, ensuring your audit trail is solid for tax purposes.
